- You may not use a motorized vehicle. No metal swords or real weapons please.
- You can decorate a stroller, wagon, tricycle or bicycle but it is optional and not required.
- Handmade floats are encouraged but not required.

Captain Billy Bowlegs and his crew will be judging the costumes and floats of each participant. Judging will take place after the final group has paraded past the judges. There will be a 1st, 2nd and 3rd place prize in each age group and an overall "Best of Show". Winners and prizes will be announced at approximately 10:30 am.
